A memorial service for the physicists is planned for next week. The hymns will be sung by the Grand Canonical Ensemble.



CWRU TO PLAY OHIO STATE IN 2008 FOOTBALL

The University Athletic Association (UAA) just released the 2008 football schedules for all teams in the conference, and in a surprise decision, Case Western Reserve University will play Ohio State in its Week 3 home opener.

"After the popularity OSU noted for its 2007 season opener against Division I-AA Youngstown State, and after the exciting victory of I-AA Appalachian State over Michigan, OSU felt that it could attract greater attention by playing a Division III school," CWRU Athletic Director Dave Diles said. "We jumped at the chance to face Ohio State in our home debut."

Diles noted that since the Buckeyes regularly draw over 100,000 fans to its football games, seating at Case Field may be limited to include only disgruntled Western Reserve University alumni still seeking reparations. Temporary bleachers will also be installed on the roofs of the Village houses.

"I think this will be a great opportunity for our third- and fourth-string players to see some action on the gridiron," Ohio State head coach Jim Tressel said. "Normally, we want to get our best players on the field, but since we're only playing Case, we can afford to give our talented people the day off."

CWRU will also hold home games against Oberlin, Brigham Young, Denison, and the Cuyahoga Community College intramural football team. The Spartans will wrap up their season at Virginia Tech in the School Shooting Bowl.



A DECLARATION...OF DISGUST

When in the course of human events it becomes necessary for people to remember the political bands which once connected them with each other and assume, among the powers of the earth, the separate and equal station to which they are entitled, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to act.

We hold these truths to be self-evident: that ALL men are created equal; that they are endowed by their Creator with certain inherent rights; that among these rights are life, liberty, and the pursuit of happiness; that to secure these rights, governments are instituted among the people, deriving their power from the consent of the governed; that whenever any form of government becomes indifferent to these rights, it is the right of the people to alter or abolish it, and institute new government, laying a new foundation on such principles and organizing its powers in such form, as to them shall seem most likely to secure their rights.

Prudence dictates that governments long established should not be changed for light and transient reasons. All experience shows that mankind is more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same object demonstrates a design not to govern, but to profit from the ability to govern, it is the right, it is the duty of the people to throw off such government and provide new guards for their future security. Such has been the patient sufferance of these people, and such is the necessity which constrains them to alter their government. The history of the present administration is a history of repeated abuses and usurpations. To prove this, let Facts be submitted to a candid world.

[The following Facts have been left in their original form where possible, but many have been altered to fit the current situation. I have tried to maintain the original spirit, but I had to cut out that last one about Indians. That was just embarrassing.]

He has refused his Assent to Laws, the most wholesome and necessary for the public good. [Stem cell funding, tax law, education reform, healthcare reform, etc, etc.]

He has forbidden Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them. [Possibly]

He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only. [Not really, unless you count enemy combatants]

He has allowed fellow party members to be called together in places luxurious, comfortable, and distant from the people they represent, for the sole purpose of coercing them into compliance with his measures. [Congressional corruption]

He has maligned representatives of the opposition repeatedly, for opposing with manly firmness his invasions on the rights of the people. [Incessantly]

He has used and abused the fear of a confused and frightened populace to ends eco-

nomic, turning popular fears to profitable opportunity for himself and others close to him. [Ever since Sept. 11]

He has endeavoured to prevent immigration to these states, obstructing the Laws for Naturalization of Foreigners, refusing to allow their migrations hither, under the guise of security, economic and national. [Immigration laws]

He has obstructed the administration of justice by assenting to laws drastically altering the establishment of Judiciary Powers. [Patriot Act]

He has made Judges dependent on his Will alone for the tenure of their offices, and the amount and payment of their salaries. [Alberto Gonzales, anyone?]

He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people and obstruct their livelihoods. [Dept. of Homeland Security, TSA, etc.]

He has kept among us, in times of peace, Standing Armies with the coerced Consent of our legislatures. [The Iraq War]

He has affected to render the Military independent of and superior to the Civil Power. [Probably]

In every stage of these actions, we have petitioned for redress in the most humble terms. Our repeated petitions and demonstrations have been answered only by repeated injury. A Prince, whose character is marked by so many acts which define a tyrant, is unfit to be the ruler of a free people.

Nor have we been unsympathetic to the plight our Republican brethren. We warned them from time to time of attempts by their leadership to extend an unwarrantable jurisdiction over us all. We reminded them of the circumstances of our emigration and settlement in this country. We appealed to their native justice and magnanimity, and we conjured them by the ties of our common kindred to excise the fool from his office, which, we grant, would inevitably damage their party's causes and reputation. Alas, they have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce to necessity and openly declare our differences. We hold them, as we hold the rest of mankind, as friends in all things but ideas.

We, therefore, representatives of the people of United States of America, in general disarray, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these States, solemnly publish and declare, that 20 January 2009 will be remembered as one of the happiest days in American history, the day that the regulated cycle of democracy proves it's worth in expelling one of the worst leaders in history from a place of power. We, the subjects of George II, remember the trials of the subjects of George III, and eagerly anticipate the days to come, when it may again become a rational act to place trust in our government to solve the problems of government, when we may again see our houses of representation as more than circuses erected for cameras, and when, just maybe, it becomes impossible to predict our nation's course based upon which party holds control of the White House. — And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.

The Charter of the Athenian

Article I. Name, Purpose, and Legitimacy/ Authority.

Section 1. Name.

The full name of this organization shall be The Athenian, Case Western Reserve University's Lampoon. The short form of this name shall be The Athenian, which shall be used in the remainder of this document. Other abbreviations used in this document are as follows:

a. "CWRU" shall denote "Case Western Reserve University"

b. "SEC" shall denote "The Student Executive Council of CWRU"

c. "Media Board" shall denote "The Student Media Board of CWRU"

Section 2. Purpose.

The Athenian is on a mission to provide humor, including but not limited to, satire and parody to the CWRU community by publishing a magazine of the same name.

Section 3. Authority.

The Athenian is a duly chartered Media Board

organization. Media Board is a duly recognized board organization of SEC. The Athenian thus enjoys the privileges and responsibilities of SEC and Media Board member organizations. As such, the charter of The Athenian shall be inferior only to the SEC constitution and the Media Board constitution, and superior to any and superior to any and all bylaws of The Athenian.

Article II. Membership

There are three types of membership in The Athenian, which are defined as:

A. Contributing Members

Hereafter referred to as "Assholes," contributing members are defined as those who have contributed to a published issue of The Athenian within the current or previous semester.

B. Advisory Members

Hereafter referred to as "Scroobs," advisory members are defined as those who do not meet the criteria for being considered Assholes or new members, yet still wish to be a part of The Athenian.

C. New Members

Hereafter referred to as "Ping Pongs," new members are defined as those who have joined the of the Editor, the Business Manager shall assume body of The Athenian for the first time during the semester in question. Previous members who have been inactive in the previous semester and who rejoin The Athenian shall be considered Scroobs.

Section 3. Removal of Members.

Candidacy for membership shall be open to duties of the Layout Editor. all undergraduate students of CWRU who are in good academic standing with CWRU and who pay of the Editor and the Business Manager and the the Student Activities Fee. The Athenian does not discriminate on the basis of age, color, course of study, creed, culture, disability, ethnic origin, fraternal membership, gender, handicap, marital status, national origin, political affiliation, race, religious beliefs, or sexual orientation in determining eligibility for membership.

Article IV. Advisor.

Section 1. Eligibility.

The advisor of The Athenian shall be a member of the faculty and staff of CWRU.

Section 2. Duties.

The advisor of The Athenian shall be responsible for the following.

Article V. Removal from Office.

Section 1. Member Petition.

A. Submission.

At any time, twenty percent (20%) of the The Layout Editor of The Athenian is respon- members of The Athenian may petition for the the advisor of The Athenian by submitting copies of their petition to all officers of The Athenian, the The Head Graphics Editor is responsible for executive committee of Media Board, and the advior advisor whom the petitioners are attempting to remove from office.

B. Calling the Meeting.

A special meeting of all members of The Athenian shall be called within seven (7) days of the receipt of the petition in Article 5 Section 1 Paragraph A. More than one petition may be considered at a given special meeting, but no other business may take place. A member of the executive council of Media Board shall call and preside over this special meeting.

C. Procedure.

i. After the meeting is called to order, roll shall be called. Quorum for the special meeting shall be half the number of members of The Athenian plus one (1). A proxy may be sent to the meeting in place of a given staff member and counted towards quorum, but no person may hold more than one vote.

ii. The petitioners shall present the reasons they are seeking the removal from office of the officer or advisor.

iii. The officer or advisor whose removal is under consideration shall then present his or her response to the presentation of the petitioners.

iv. The members of The Athenian present at the meeting shall then vote by secret ballot on the removal of the officer or advisor in question. A two-thirds (2/3) majority of those members of The Athenian present shall be required to remove from office the officer or advisor in question.

v. If more than one petition for removal from office is under consideration, the procedure outlined in Article V, Section 1, Paragraph C, Subparagraphs ii-iv shall be repeated separately for each petition under consideration.

Section 2. Media Board Decision.

Pursuant to Media Board Constitution Article IX, Section 3, Media Board shall have the power to remove the Editor, Business Manager, or advisor of The Athenian by a two-thirds (2/3) vote.

Article VI. Publication

Section 1. Schedule.

Depending upon contributions from Assholes, The Athenian will strive to publish three (3) issues per semester.

Section 2. The Observer.

Each issue shall include no less than one (1) joke of which The Observer is the butt.

Article VII. Meetings.

The Editor shall call meetings no less than once per issue.

Article VIII. Bylaws

Section 1.

Bylaws of The Athenian shall be inferior to and consistent with this charter.

Section 2.

Amendments to the bylaws of The Athenian may be proposed at any time, without prior notice.

Section 3.

Amendments to the bylaws of The Athenian shall require approval by a two-thirds (2/3) majority of Assholes.

Section 4.

All members of The Athenian shall be notified of an amendment to the bylaws of The Athenian within three (3) days of the ratification of the amendment.

Article IX. Ratification and Amendments.

Section 1. Ratification.

In order to ratify this charter, the following must occur:

A. The charter must be approved by a twothirds (2/3) majority of Assholes; and,

B. The charter must be approved by the advisor of The Athenian.

Section 2. Amendments.

A. Proposing Amendments.

i. An amendment to this charter must be proposed by at least two (2) members.

ii. Members must be informed of a proposed amendment no less than seven (7) days prior to voting on the amendment.

B. Ratifying Amendments.

Amendments to this charter must be approved by a two-thirds (2/3) majority of Assholes.

Section 3. Filing.

A copy of this charter once ratified and of amended versions of this charter once ratified shall be placed on file with the advisor of Media Board.


